16. Multidisciplinary / interdisciplinary

- a) The vision/plan of the institution to transform itself into a holistic multidisciplinary institution is centered around promoting a comprehensive and integrated learning experience that nurtures creativity, critical thinking, problem-solving, and well-rounded development of students. The institution aims to achieve this transformation through the following strategies:
 - 1. Integrating Humanities, Arts & Social Sciences (HSS) with Science, Technology, Engineering & Mathematics (STEM)
 - Open electives and choice based projects are provided to students across all discipline of study, students can also option for courses online on portals such as SWAYAM, NPTEL, and COURSERA and so on
 - 3. It integrates practical vocational training and soft skills development into the curriculum to enhance students' employability and overall effectiveness in professional settings.
 - 4. More emphasis on research, debate, communication, and interpersonal skills:
 - 5. Hybrid courses, cross-disciplinary, and interdisciplinary approach
 - 6. Innovative curriculum in community engagement, environmental education, and value-based education. Students are encouraged to conduct research work in the adopted villages of the institution, international and national commemorative days such as blood donor day, women's day, children's day, environment day are organised with active participation of the

- students.
- 7. Students and faculty exchange programs, university tie-ups to broaden students' horizons and promote cultural exchange. AdtU has MoU with several other universities both in India and abroad such as INTI International University, Bangladesh, Assam Engineering College, etc.
- b) Assam down town University under the NEP 2020 guidelines is slowly transforming the regular STEM courses into the new modern STEAM course format with seamless integration of arts and science. The University currently provides courses with electives from any of science or humanities. For example: Under Humanities & Social Sciences, a learner can pursue M.Sc in Clinical Psychology wherein Statistics and data analytics, research methodology in behavioral sciences are also part of it.
- c) Yes, the institution places a strong emphasis on providing a flexible and innovative curriculum that promotes holistic and multidisciplinary education. The curriculum is designed to include credit-based courses and projects in the following areas: community engagement and service, environmental education, and value-based learning. It comprises of credit based courses, community engagements and service projects, environmental education, value-based learning, Innovation in teaching and learning, regular curriculum review.
- d) The university will organize training and professional development programme for Faculty members to familiarize them with the new curriculum structure and teaching methodologies. Simultaneously, an enhancement of technological infrastructure to support online, blended learning and integration of digital tools, elearning platforms, followed by development of virtual labs to meet the learning experience of students at par with the quality standard recommended in NEP2020
- e) The institution is committed to fostering multidisciplinary research endeavors to address society's most pressing issues and challenges effectively. It includes establishment of research centres, interdisciplinary research grants, institutional research symposium and conferences, graduate programs with interdisciplinary focus, industry & community partnerships, research incubators and innovation labs, trans-disciplinary curriculum and training, public policy and advocacy initiatives and global collaborations.
- f) The institution has successfully implemented several good practices to promote a multidisciplinary and interdisciplinary

approach in line with the National Education Policy (NEP) 2020 such as Interdisciplinary seminars and workshops, Interdisciplinary Student Clubs and Societies and awarded recognitions.

17.Academic bank of credits (ABC):

- a) AdtU has initiated process related to Academic bank of credits as proposed in NEP 2020. The University is finalizing a road map on the seamless integration of ABC guidelines into its governance by enabling the credit accumulation system, flexible course structure, online credit portal, credit transfer agreements and tie-ups with other universities, integration of vocational and skill based credit courses, credit banking and top up, and a transparent credit transfer policy.
- b) The institution is currently not registered under the ABC to permit its learners to avail the multiple entries and exit during any chosen programme.
- c) AdtU is making huge efforts in establishing a seamless collaboration with various national and international universities for both faculty and student exchange programs and exploring the prospects in expansion and internationalization of education. It has institutional MoU's with various organizations such as Ashok Institute, CSIR-NEIST, and Council for Technical Education and Vocational Training, IIT Guwahati etc. and also has MoU's with international universities such as Tribhuvan University, Sonargaon University, Krida Wacana, Christian University, Philippine Normal University etc. The process of credit transfer policy is still in its nascent stages of development.
- d) AdtU stresses on an exhaustive and extensive curriculum with its framework to ensure that it encompasses various aspects of an Outcome Based Education (OBE). The deans are provided a certain degree of autonomy to make decisions regarding curriculum design, teaching methods and assessment formats as long as they align with overall goals and standards of the institution. AdtU also encourages on an open and inclusive environment where faculties can discuss their ideas and concerns with administrators and peers that encourages creativity and adaptability. Faculties are also emphasized on a learner centric approach while designing their curricula and teaching methods to accommodate diverse learning styles and improve the scope of differential learning. Faculties are also subjected to various academic exposures such as FDP programmes, webinars, workshops etc that provide training and support for designing innovative curricula and adopting effective pedagogical

techniques. Faculties are also provided with access to resources, research materials, and technology to facilitate their curriculum and development process and enhance the learning experience. To foster a dynamic and engaging learning environment that meets the needs of both educators and students, the University empowers its faculties to have a say in the curriculum design and pedagogy and also seeks the support of external academic inputs to make it an overall richer experience.

- e) Although the concept of Academic Bank of Credits (ABC) is still in its preliminary stage, yet the AdtU is already making active efforts to encompass various good practices such as Transparent Credit system, Credit Accumulation and Transfer, Credit Recognition for Prior Learning, Credit Transfer Mechanism, Credit Banking and Transcript. The University is already engaged in other good practices such as:
 - Learning Outcome Based Approach wherein focus on clear and tangible learning outcomes for each course or program is clearly defined on its website.
 - Academic and Career Counseling that offers counseling services to help students make informed decisions about career pathways ensuring proper planning for their future.
 - Faculty Training wherein faculties receive training and support to design courses with clear learning outcomes and assessments.

18.Skill development:

- a) AdtU focuses on strengthening vocational education and soft skills in alignment with the National Skills Qualifications
 Framework (NSQF) through various initiatives and strategies. These include curriculum alignment, skill-based training, industry partnerships, certification and accreditation, soft skills development, career counseling, internship opportunities, assessment and evaluation, continuous improvement, and placement assistance. The institution aims to provide students with the skills and competencies demanded by the job market, enhancing their technical skills and providing exposure to real-world scenarios. AdtU also collaborates with industries and employers to design and deliver vocational programs that meet current market demands. The institution's commitment to continuous improvement and placement assistance ensures that its vocational education programs remain relevant and effective.
- b) The institution offers various optional courses to encourage

vocational education and integrate it into mainstream education. These include Humanities and Social Sciences, Commerce and Management, Pharmaceutical Science, Paramedical Sciences, Engineering & Technology Sciences, Nursing, Science, and Science. Courses cover social problems, positive psychology, legal system, life skills, mindfulness, NGO administration, Indian society studies, project management, and social entrepreneurship.

- c) The institution is dedicated to offering value-based education to students in order to promote positivism and holistic development. It includes a holistic strategy that focuses on the development of humanistic, ethical, constitutional, and universal human values. The institution incorporates value-based components into all academic area and ensures that students are exposed to these principles in a variety of circumstances, boosting comprehension and internalisation. Each programme offered by the university includes an ethical subject pertinent to the course, ensuring that students receive ethical education as part of their educational experience.
- d) The school has established a credit structure that requires all students to complete at least one vocational course before graduating. This is accomplished by introducing occupational courses as part of the degree requirements into the curriculum. By granting credit for various courses, the school encourages students to pursue diverse vocational interests while also providing them with practical skills. The institute works with industry veterans and Master Craftspeople to bridge the gap between theoretical knowledge and practical requirements. These accomplished individuals act as guest faculty or mentors, passing on occupational skills gained via real-world experience. Their knowledge enhances the learning process.
- e) AdtU is committed to enhancing skill development in line with the National Education Policy 2020. The university has established partnerships with industrial organizations, such as Guwahati Bio Tech Park, etc. providing students with hands-on learning experiences. AdtU also fosters connections with organizations like VIMS Hospital, Takshila Hotels Pvt. Ltd. etc. for placement opportunities, ensuring graduates are well-prepared for the job market. The university has Entrepreneurship and Business Incubation Cell, down town Venture Labs, which supports and guides aspiring entrepreneurs. Soft skills training are provided to both students and faculty members, Internship programs are available for students, and faculty members are encouraged to participate in faculty development programs, trainings, and conferences. AdtU's Career Counseling Wing guides students in making informed career choices,

aligning their career goals with their interests and strengths.

19. Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course)

- a) Assam down town University is engaged in continuously evolving the seamless integration of Indian Knowledge System into the curriculum via either the offline, online mode or both. It follows a detailed strategy often comprising of Curriculum Review to identify areas where Indian Knowledge can be seamlessly integrated onto the educational curriculum. Then the finalized curriculum is to be reviewed by subject matter experts both from inside and outside the University. Teacher training, Outreach and awareness, Research and Innovation, Assessment and evaluation are all other strategies that are being implemented to offer a holistic blended learning to the students. Currently Faculty of Humanities and Social Sciences under Performing Arts programme offer variety of courses such as Sociological concepts and Indian Society, Indian Culture and Art, Concept of Hindustani Classical Music/Indian Classical Dance/Drama, Essence of Indian Traditional Knowledge etc. Moreover essence of Indian Traditional Knowledge is offered as an online course on SWAYAM by the Faculty of Engineering & Technology.
- b) AdtU has the follows a comprehensive institutional plan (on a need to basis) to train its faculties to provide the classroom delivery in bilingual mode. It comprises of need assessment, language proficiency training, pedagogical training, English language lab, practice sessions, guest lectures and workshops, peer collaboration
- c) Owing to the linguistic diversity of the learners in Assam down town University and based on feedback from faculties and learners alike the classroom delivery is already being done in bilingual mode. The University is planning to phase out courses in Indian languages and bilingually based on further feedback from learners and faculties.
- d) The institution has undertaken comprehensive and dedicated efforts to preserve and promote various aspects of Indian heritage, including Indian languages, Indian ancient traditional knowledge, Indian arts, Indian culture and traditions,
- e) Assam down town University as part of its institutional good practice pertaining to Indian Knowledge System often conducts online cultural events, festivals and seminars that celebrate India's diverse cultural heritage fostering a sense of pride and identity

among the learners. AdtU also emphasizes the study and appreciation of indigenous knowledge systems and their traditional practices showing their relevance in the modern context. Incorporating multimedia elements like videos, infographics and visuals to enhance the learning experience and make cultural concepts more understandable. Blended libraries and repositories of Indian literature, music, art and other historical resources allow the learners to explore the vast Indian Cultural Heritage. Posters and photoframes of various cultural art and dance forms along with brief description can be found throughout the campus.

20. Focus on Outcome based education (OBE): Focus on Outcome based education (OBE):

- i) The institution has implemented comprehensive measures to align its curriculum with Outcome-Based Education (OBE) principles. This approach focuses on defining specific learning outcomes for students to achieve by the end of their academic programs. Initiatives such as learning outcome mapping, collaboration among faculty to establish clear and measurable learning objectives, and curriculum restructuring to emphasize practical application and real-world relevance are part of this transformation. The institution promotes a student-centric approach, encouraging active student engagement and goal-setting. Moreover, stakeholders, including faculty, students, industry experts, and alumni, are actively involved in the OBE implementation process through regular feedback and discussions, ensuring continuous improvement and alignment with their evolving needs.
- ii) The institution has implemented various strategies to effectively incorporate Outcome-Based Education (OBE) in its teaching and learning practices, ensuring continuous assessment of students' progress and achievement of learning outcomes. These strategies include competency-based instruction, employing active learning techniques, group projects, case studies, and problemsolving exercises to develop students' practical skills. Continuous formative assessments are used to monitor students' strengths and weaknesses, enabling timely support for their learning needs. Additionally, project-based learning encourages critical thinking, teamwork, and problem-solving abilities, aligning with the application-oriented philosophy of OBE. The institution utilizes learning analytics to track students' performance and engagement, allowing evidence-based improvements in teaching strategies. Moreover, industry integration through guest lectures, workshops, and internships ensures students gain practical exposure, enhancing their employability in line with industry demands.

iii) The institution's notable good practice related to OBE and in alignment with NEP 2020 is the comprehensive implementation of a Learning Outcomes Assessment System. This system surpasses traditional examinations and evaluates students based on demonstrated skills and competencies. It employs a multi-dimensional assessment approach, combining various methods to holistically evaluate students' abilities. Additionally, personalized learning plans cater to individual learning needs, promoting inclusive education. Students maintain skill development portfolios to record progress related to defined learning outcomes. Encouraging a culture of continuous improvement, the institution embraces peer and self-assessment, empowering students to evaluate their progress actively. Furthermore, collaboration with external bodies and industry experts validates the effectiveness of the OBE implementation, ensuring alignment with national and international standards.

In conclusion, the institution's initiatives towards Outcome-Based Education, efforts in teaching and learning practices, and the implementation of a Learning Outcomes Assessment System demonstrate a strong commitment to quality education and student-centric learning. By integrating OBE principles, the institution prepares students to be competent, skillful, and adaptable individuals, ready to excel in their careers and contribute meaningfully to society in alignment with the vision of NEP 2020.

21.Distance education/online education:

- a) While AdtU currently does not have a distance education program, there are significant possibilities for offering vocational courses through Open and Distance Learning (ODL) mode in the future. ODL can provide access to vocational education for a wider audience, including working professionals, students from remote areas, and those with other commitments. By leveraging digital platforms and online resources, the institution can design ODL courses that incorporate practical training, simulations, and interactive assessments, allowing students to acquire vocational skills remotely. Additionally, the institution can collaborate with industry partners to facilitate practical training and internships at local centers, ensuring hands-on experience for ODL students. This mode of education can create a flexible and accessible learning environment, aligning with the National Education Policy (NEP) 2020's vision of expanding the reach of quality education.
- b) The institution recognizes the significance of technological tools for enhancing teaching-learning activities and has made efforts towards blended learning. Blended learning combines

traditional classroom instruction with online elements, promoting a more dynamic and interactive learning experience. The institution has integrated various technological tools, such as Learning Management Systems (LMS), video conferencing platforms, and multimedia resources, to facilitate online lectures, assignments, and discussions. Faculty members receive training and support to effectively utilize these tools to engage students actively. Additionally, the institution encourages flipped classroom models, where students access instructional content online before attending in-person classes for discussions and practical application. Blended learning allows students to learn at their own pace while benefiting from face-to-face interactions with peers and faculty. These efforts align with NEP 2020's emphasis on digital learning and the integration of technology in education.

Good practices of the institution pertaining to Distance Education/Online Education in view of NEP 2020:

In alignment with NEP 2020, AdtU has demonstrated a forward-thinking approach by considering the possibilities of offering vocational courses through ODL mode. The institution's readiness to explore this avenue showcases its commitment to expanding access to education and reaching diverse learners through flexible learning options. Moreover, the institution's focus on developing and utilizing technological tools for blended learning reflects its adaptability to the changing educational landscape. By incorporating digital elements into the teaching-learning process, AdtU aims to create an enriched and interactive learning environment for students. These proactive initiatives signify the institution's efforts to align with NEP 2020's vision of promoting online education and leveraging technology to enhance the quality of education.

1.3 - Curriculum Enrichment

1.3.1 - Institution integrates crosscutting issues relevant to Professional Ethics, Gender, Human Values, Environment and Sustainability into the Curriculum

All faculties of AdtU have incorporated the fundamental principles of professional ethics and ethical guidelines into their respective programs. This initiative aims to equip students with the necessary knowledge and skills to become responsible professionals who adhere to a code of conduct, exhibit appropriate professional behavior, and interact effectively with clients. Various subjects related to professional ethics, gender equality, and human values have been integrated into the curricula of relevant professions, allowing students to learn about professional ethics and incorporate them into their practice. The University's gender-related courses also cover gender sensitivity issues and provide cross-cultural knowledge on gender equality and women's empowerment. The undergraduate and postgraduate programs include numerous courses that focus on developing human values and professional ethics. To handle liquid waste the University has various toilets, washrooms and lavaratories wherein the waste is properly channeled through storm sewers and drains throughout the campus. The university also has Sewage storage tanks located throughout the campus.

Assam down town University implements a comprehensive and impartial evaluation process. Each program offered by the university follows a distinct set of Examination Regulations that guide the examination process. The university adopts a continuous evaluation system, and students are evaluated based on their insemester and end-semester performance. The mode of evaluation for all courses across faculties follows a 40:60 ratio, where 40% is allocated to in-semester performance, and 60% is given to endsemester performance. Information technology (IT) plays a critical role in the evaluation process, with respective faculties entering the students' scores in the ERP system for answer script evaluation. The system then automatically calculates and updates the grades in the Cumulative Grade Point Average by considering the Semester Grade Point Average. The ERP displays the result sheet after the marks' scrutiny, and students can print their e-mark sheets as needed until the final marksheets are issued.

Assam down town University offers comprehensive infrastructure and facilities to support teaching and learning. It has 204 spacious classrooms, among which 58 are smart classrooms equipped with modern technology to enhance teaching efficiency. The institution also provides access to 67 laboratories, 3

The University aims to refine and digitize the academic planning process, and has achieved this objective by using advanced and innovative teaching tools such as ICT-enabled tools like ERP and PRAN.

The University provides high-speed internet to all departments, administrative offices, campus hostels, and libraries. The library offers academic and scholarly materials such as econtents, e-research journals, papers, and more, which can be accessed from anywhere via the e-portal of the library. The institution also provides various e-resources portals like Delnet, JGATE, NDLI, etc.

To further achieve its goals, the institution has made it mandatory for students to undergo e-learning courses, after which they receive an e-certificate. AdtU has more than 10 smart classrooms and 55+ ICT-enabled classrooms that include various ICT tools such as laptops, computers, high-end projectors, audio-video recording mediums, video conferencing halls, video and audio lectures, e-contents, and online communication mediums.

Due to its outstanding efforts towards academic digitization, AdtU has been awarded a certificate of "E-Learning Excellence for Academic Digitization" by QS IGAUGE.

To handle liquid waste the University has various toilets, washrooms and lavaratories wherein the waste is properly channeled through storm sewers and drains throughout the campus. The university also has Sewage storage tanks located throughout
